

Preparation and submission of all documents required for the approval of permits & endorsements for such proposed modernization and general repairs, and, Performance of all construction works needed to complete proposed repairs, improvements and modernization of civil/architectural facilities, mechanical systems (plumbing and air conditioning), and electrical systems (electric power supply & distribution, illumination, and voice/data communications). All design professional services and construction works shall be provided and performed in accordance with Contract Documents submitted as part of this RFP, and all updated applicable federal, state, and local construction standards, codes, laws, and regulations.
